Director, Master of Public Policy (MPP) Program, University of Michigan-Dearborn, 2004-2005. First director of this program, and also the principal author of the proposal creating this program. Chair, Master of Public Policy Committee, Univ. of Michigan-Dearborn, 2000-2004. This committee drafted the plan to create a Master of Public Policy degree program (adopted by the University of Michigan Regents, July 2004).

Director (and Principal Investigator for funding from Canadian Studies Grants): Ottawa Internship Program in the Canadian House of Commons, 2005-2009. As Director I secured, from the Canadian Department of Foreign Affairs and Trade (DFAIT), an annual program enhancement grant for the Ottawa public affairs internship (typically enrolling with about 75% UM-AA students, 20% UM-D students, 5% others). I managed the transfer of the program's administration from the Ann Arbor campus to its original home at UM-Dearborn, after 11 years away, as I became its Director, in 2005-2006. Annual grant renewals: 2006-07, 2007-2008, 2008-2009, and 2009-2010. In a related Canadian Studies curricular development, I drafted the plan, adopted in 2006, for a joint MPP-MA degree in Canadian and U.S. Public Policy with the Univ. of Windsor, which enrolled students from USA and Canada.

Co-Chair, University of Michigan-Dearborn Self-Study Steering Committee for Accreditation by the North Central Association of Colleges and Schools, Commission on Institutions of Higher Education, 1990-1993. We conducted a special emphasis self-study with the focus on strategic planning.

Director, Division of Inter-Disciplinary Studies (IDS), University of Michigan-Dearborn, 1981-1986. In this capacity, I reported to the Vice Chancellor for Academic Affairs (Provost); was a member of the Council of Deans (consisting of the Provost and the 5 heads of the academic units on campus); and was responsible for the unit's 70 graduate and 450 undergraduate students, who were enrolled in its degree programs in computer science and information systems, environmental studies, health policy and administration, urban studies, and public administration. Executive Officer, IDS, University of Michigan-Dearborn, 1977-1981.

Acting Chairman, Department of Social Sciences, University of Michigan-Dearborn, Spring Term, 1976. Chair, Political Science Discipline, University of Michigan-Dearborn, Winter 1979, and January 1988-April 1989, and Sept. 1996-June 1997.

Member, Raoul Wallenberg Executive Committee, Wallenberg Endowment (http://wallenberg.umich.edu/index.html), Univ. of Michigan, 2002-present. Wallenberg (UM class of 1935) saved tens of thousands of people in Hungary during the Holocaust by granting them Swedish diplomatic protection; imprisoned by the invading Soviet forces in 1945, Wallenberg died in the Gulag; he is the 2nd person (Winston Churchill is the first) to become an honorary U.S. citizen. To encourage UM students to make humanitarian efforts in other countries, the Committee began sponsoring students as Wallenberg International Travel Fellows in summer 2007; several students each year engage in community service or civic participation (such as one engineering student who designed and installed potable drinking water systems in Kenyan elementary schools). The Wallenberg Committee also works with the Assistant Dean of Rackham for International Education to select the Wallenberg Medalist, a courageous person such as Raoul Wallenberg who has made a difference in a humanitarian crisis. Recent well-known recipients include Paul Rusesabagina (our 2005 medalist), popularly known as the heroic central character of the film "Hotel Rwanda." We have also recently honored Desmond Tutu (2008) and Aung San Suu Kyi

(<a href="http://www.ur.umich.edu/update/archives/111026/wallenberg">http://www.ur.umich.edu/update/archives/111026/wallenberg</a>, 2011), two Nobelists. The presentation to Aung San Suu Kyi came at a critical moment when she was likely to soon be released from decades of enforced silence and house arrest during Burmese military rule, and so was a timely recognition on our part, which she appreciated; because of the delicate situation, she was the only Medalist to speak to our audience via video teleconferencing, from her home. In 2014, the Nobel Peace Prize went to Kailash Satyarthi, to whom we had awarded our Medal back in 2002 as part of our effort to shine light on little-recognized, vulnerable, and important humanitarian endeavors. Such work can here can be summed up in the words of Paul Rusesabagina, in concluding his address to us: "Tonight I am a Wallenberg. Each one of you can be a Wallenberg."
