### SERVICE AND FEE SCHEDULE

#### • REGULAR SERVICE •

**Fee includes postage.**

Copy in U.S. Mail within five working days from our receipt of the request.

##### FEES:

- (a) Regular photocopies  
\$10 per document up to 50 pages,  
\$5 per 50 page increment  
thereafter.
- (b) Paper printed from microfiche:  
\$10 per document for the first  
15 pages, \$1 per page thereafter.
- (c) Microfiche copy from  
microfiche: \$10 per fiche  
(Equivalent of 98 pages).

Please note that we will put the copy in the mail within a workweek; it will take a few more days to arrive. In general, you should count on having the document within a week to ten days.

#### • SERVICE TO FOREIGN COUNTRIES •

(Including Canada)

The minimum charge for duplicating and sending material will be \$15.00. Otherwise, our usual fees will apply, plus airmail charges.

#### • RUSH SERVICE •

Copy will be sent by overnight delivery service, or by telefax, the same working day if the request is received by noon.

##### FEES:

- (a) Regular photocopies: \$20.00 per document up to 50 pages, \$5 per 50 page increment thereafter, **plus** fax charges of \$1 per page faxed or delivery service charges.
- (b) Paper printed from microfiche: \$20.00 per document up to 15 pages, \$1 per page thereafter, **plus** fax charges of \$1 per page faxed or delivery service charges.
- (c) Microfiche copy from microfiche: \$20.00 per fiche, **plus** delivery service charges.  
(Fax not possible)

If FAX, leave us your fax number and the hours the machine is in operation. We will add to your bill \$1 per page faxed, excluding title pages and cover sheets.

If OVERNIGHT DELIVERY, we use DHL or Federal Express. If you prefer one, tell us. If you have an account with either, we can charge the shipping expenses to your account. Otherwise, we will add the shipping charges to your invoice.

Please note overnight delivery can only be made to a street address.

#### INSTRUCTIONS:

Call or fax us at the respective numbers above. The phone number is an answering machine. You can leave citation and service-wanted information on the machine, or we will return your call. Be sure and leave your number, including area code. The machine is checked at noon daily, Monday through Friday. Requests can also be faxed. All charges are **per citation**. Do not pre-pay; an invoice will follow in a few weeks. See over, for more information.
